# **COLONEL SHANNON L. SHERWIN**

Colonel Shannon L. Sherwin is the Staff Judge Advocate, Headquarters Air Education and Training Command (AETC), Joint Base San Antonio-Randolph, TX. AETC is responsible for the recruiting, training, and education of Air Force personnel. The Office of the Staff Judge Advocate establishes policy oversight for 14 legal offices, including six general court-martial jurisdictions, which provide legal services to over 62,000 active duty, Reserve, and Guard personnel.

Col Sherwin received a direct commission as an Air Force judge advocate in November 1997 and entered active duty in January 1998. She has served as a headquarters director; an installation, deployed, and Numbered Air Force staff judge advocate; an installation and Major Command deputy staff judge advocate; legal advisor to the Combat Operations Division at the Combined Air and Space Operations Center and legal advisor to the 603rd Air and Space Operations Center. She is admitted to practice law before the United States Supreme Court,



United States Court of Appeals for the Armed Forces, and the Supreme Court of the State of Colorado. Prior to her current position, Col Sherwin was the Director and Chief Information Officer, Legal Information Services Directorate, Headquarters Air Force, Maxwell, Air Force Base Alabama.
