Colonel Andrea M. deCamara is the Staff Judge Advocate, Headquarters Air Education and Training Command (AETC), Joint Base San Antonio-Randolph, TX. AETC is responsible for the recruiting, training, and education of Air Force personnel. The Office of the Staff Judge Advocate establishes policy oversight for 14 legal offices, including five general court-martial jurisdictions, which provide legal services to over 62,000 active duty, Reserve, and Guard personnel.

Col deCamara was born at Patrick Air Force Base, Florida. She received a direct commission in March 1997 and entered the Air Force in April 1997. Col deCamara has served in various positions at all levels of command including as an Area Defense Counsel, Appellate Defense Counsel, Executive Officer, Division Chief, a Deputy Staff Judge Advocate and Staff Judge Advocate. She is admitted to practice law in the Commonwealth of Massachussetts, the Supreme Court of the United States and the United States Court of Appeals for the Armed Forces.
